# The United States of America,

To all to whom these presents shall come, Greeting:

WHEREAS, In pursuance of the provisions of the Revised Statutes of the United States, Chapter Six, Title Thirty-two, and legislation supplemental thereto, there have been deposited in the General Land Office of the United States the Plat and Field Notes of Survey and the Certificate of the Register of the Land Office at Sacramento, California, accompanied by other evidence whereby it appears that The Iron Mountain Investment Company

has entered and paid for the Oversight, Foresight, and Backsight lode mining claims

designated by the Survey of the General Land Office as Survey No. 5936, embracing a portion of Sections twenty-seven, twenty-eight, and thirty-three in Township thirty-three north of Range six west of the Mount Diablo Meridian, in the Flat Creek Mining District, Sasta County, California,

and bounded, described, and platted as follows: Beginning for the description of the Oversight lode claim, at corner No. 1, an iron pipe thirty inches long, two inches in diameter, with brass cap marked O 1 5936, with mound of stone, from which the corner to Sections twenty-seven, twenty-eight, thirty-three, and thirty-four in Township thirty-three north of Range six west of the Mount Diablo Meridian, bears south one degree forty minutes west three hundred eighty-one and six-hundredths feet distant;

Thence, first course, south one degree forty minutes west three hundred eighty-one and six-hundredths feet to the southwest corner of the southwest quarter of the southwest quarter of Section twenty-seven in Township thirty-three north of Range six west of the Mount Diablo Meridian; one thousand four hundred ninety-nine and sixty-seven-hundredths feet to corner No. 2 an iron pipe thirty inches long, two inches in

diameter with brass cap marked O 2 5936;

Thence, second course, west six hundred feet to corner No. 3, an iron pipe thirty inches long two inches in diameter, with brass cap marked O 3 F 2 B 4 5936;

Thence, third course, north one degree forty minutes east one thousand four hundred ninety-nine and sixty-seven-hundredths feet to corner No. 4, an iron pipe thirty inches long, two inches in diameter with brass cap marked O 4 F I 1 5936;

Thence, fourth course, east three hundred feet to a point from which discovery tunnel bears south one degree forty minutes west three hundred ten feet distant; five hundred eighty-five and one-tenth feet intersect the west boundary of said southwest quarter of the southwest quarter of Section twenty-seven, at north thirty-four minutes thirty-one seconds west three hundred eighty and ninety-one-hundredths feet from the southwest corner; six hundred feet to corner No. 1, the place of beginning; the survey of the lode claim, as above described, extending one thousand four hundred ninety-nine and sixty-seven-hundredths feet in length along said Oversight vein or lode;

Beginning, for the description of the Foresight lode claim, at corner No. 1, identical with corner No. 4 of said Oversight lode claim, from which said section corner bears south fifty-seven degrees six minutes twenty-four seconds east seven hundred one and thirty-five hundredths feet distant;

Thence, first course, south one degree forty minutes west one thousand four hundred ninety-nine and sixty-seven-hundredths feet to corner No. 2, identical with corner No. 3 of said Oversight lode claim;

Thence, second course, west six hundred feet to corner No. 3, an iron pipe thirty inches long, two inches in diameter, with brass cap marked F 3 B 3 5936;

Thence, third course, north one degree forty minutes east one thousand four hundred ninety-nine and sixty-seven-hundredths feet to corner No. 4, an iron pipe thirty inches long, two inches in diameter with brass cap marked F 4 5936;

Thence, fourth course, east three hundred feet to a point from which discovery bears south one degree forty minutes west one thousand two hundred ninety-nine and sixty-seven-hundredths feet distant; six hundred feet to corner No. 1, the place of beginning; the survey of the lode claim, as above described, extending one thousand four hundred ninety-nine and sixty-seven-hundredths feet in length along said Foresight vein or lode;

Beginning, for the description of the Backsight lode claim, at corner No. 1, an iron pipe one and one-half inches in diameter, eighteen inches above ground, with cap marked B 1 5936 F G 2 5437; identical with corner No. 2 of Survey No. 5437 the Fine Gold lode claim, from which the east quarter corner to said Section thirty-three bears east six hundred feet distant;

Thence, first course, west three hundred feet to a point from which discovery bears north one degree forty minutes east one thousand eighty feet distant; six hundred feet to corner No. 2, an iron pipe thirty inches long, two inches in diameter, with brass cap marked B 2 5936;

Thence, second course, north one degree forty minutes east one thousand five hundred feet to corner No. 3, identical with corner No. 3 of said Foresight lode claim;

Thence, third course, east five hundred fifty-six and thirty-eight-hundredths feet to corner No. 3 of said Survey No. 5437; six hundred feet to corner No. 4 identical with corner No. 2 of said Foresight lode claim;

Thence, fourth course, south one degree forty minutes west one thousand five hundred feet to corner No. 1, the place of beginning; the survey of the lode claim, as above described, extending one thousand five hundred feet in length along said Backsight vein or lode;-expressly excepting and excluding from these presents all that portion of the ground hereinbefore described, embraced in said mining claim or Survey No. 5437 and said southwest quarter of the southwest quarter of Section twenty-seven, and also all veins, lodes, and ledges, throughout their entire depth, the tops or apexes of which lie inside of such excluded ground; the premises herein granted, containing sixty-one acres and one hundred thirty-one thousandths of an acre.

NOW KNOW YE, That there is therefore, pursuant to the laws aforesaid, hereby granted by the United States unto the said  
**The Iron Mountain Investment Company**

the said mining premises hereinbefore described, and not expressly excepted from these presents, and all that portion of the said vein **S**, lode **S** or ledge **S** and of all other veins, lodes, and ledges throughout their entire depth, the tops or apexes of which lie inside of the surface boundary lines of said granted premises in said survey extended downward vertically, although such veins, lodes, or ledges in their downward course may so far depart from a perpendicular as to extend outside the vertical side lines of said premises: Provided, That the right of possession to such outside parts of said veins, lodes, or ledges shall be confined to such portions thereof as lie between vertical planes drawn downward through the end lines of said survey so continued in their own direction that such planes will intersect such exterior parts of said veins, lodes, or ledges: And provided further, That nothing herein contained shall authorize the grantee herein to enter upon the surface of a claim owned or possessed by another.

TO HAVE AND TO HOLD said mining premises, together with all the rights, privileges, immunities, and appurtenances of whatsoever nature thereunto belonging, unto the said grantee above named and to **its successors** and assigns forever; subject, nevertheless, to the above-mentioned and to the following conditions and stipulations:

FIRST. That the premises hereby granted shall be held subject to any vested and accrued water rights for mining, agricultural, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local laws, customs, and decisions of the courts. And there is reserved from the lands hereby granted a right of way thereon for ditches or canals constructed by the authority of the United States.

SECOND. That in the absence of necessary legislation by Congress, the Legislature of **California** may provide rules for working the mining claim or premises hereby granted, involving easements, drainage, and other necessary means to its complete development.
